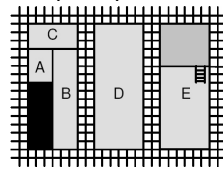

5. ADDITIONAL PROVISIONS

- 5.1. Exhibitor confirms hereby his participation in the Exhibition and undertakes to observe the requirements of Exhibitor's Manual and all rules (fire safety, sanitary and other rules) existing in the territory of the Exhibition (such rules may be forwarded to Exhibitor upon his request).
- 5.2. Exhibitor also confirms his obligation to pay in full his participation in the Exhibition in accordance with the procedures set forth in this Agreement, acknowledges that the Organiser has incurred expenditures for the purpose of proper fulfillment of this Agreement, and undertakes not to request refunding of money that has been paid and actually spent by the Organiser for such purposes.
- 5.3. Any additional (technical, marketing and other) services will be provided by the Organisers on the basis of separate applications submitted by Exhibitor in accordance with the forms set out in Exhibitor's Manual, or, if services requested by Exhibitor are not provided for, on the basis of agreements additionally signed between them, and such services shall be paid for in accordance with separate invoices issued.
- 5.4. In case of any breach by Exhibitor of payment procedures, the Organiser has the right unilaterally and extrajudicially to change the space, type and/or location of Exhibitor's stand, or to terminate fulfillment of the Agreement until the payment is made.
- 5.5. Exhibitor bears individual liability for displaying exhibits and/or distribution of materials, documents and other information, inconsistent with the requirements of the existing legislation or without a special permission to do so (if it is required), and for non-execution of visa, customs and other documents, which are necessary to get to the exhibition ground.
- 5.6. Exhibitor has the right to unilaterally terminate this Agreement without reimbursing any losses by sending a written notification about it not later than 9 (nine) months before the beginning of the Exhibition, or after the above date upon payment of the following compensation to the Organiser:
 - 5.6.1. 10% of the total cost of participation – in case such notification is sent during the period from 9 (nine) to 6 (six) months before the beginning of the Exhibition;
 - 5.6.2. 50% of the total cost of participation – in case such notification is sent during the period from 6 (six) to 3 (three) months before the beginning of the Exhibition;
 - 5.6.3. 100% of the total cost of participation – in case such notification is sent less than 3 (three) months before the beginning of the Exhibition.
- 5.7. Obligations of the Organiser under this Agreement are considered to be fulfilled from the date of signing by the Parties of a Delivery/Acceptance Act. Any claims in regard to the fulfillment of this Agreement may be sent to the Organiser within five working days upon completion of the Exhibition. In case no claims are presented within the period set out in this Clause, this Agreement is considered to be duly fulfilled in full, and such Act is considered to be signed by the Parties.
- 5.8. The overall amount of the Organiser's liability in case of violation of this Agreement may not exceed the amount specified in P. 3.3.
- 5.9. The Organiser is not liable for losses and any other damages and/or costs of Exhibitor, if relocation or cancellation of the Exhibition occurred for reasons beyond the Organiser's control.
- 5.10. In case force majeure occurs during the fulfillment of this Agreement, the Parties (1) will be released from liability, if proper fulfillment of the Agreement appears to be impossible and (2) shall agree upon the necessity to continue the fulfillment of this Agreement.


